With reference to your order dated 25th August, 1927, forwarded with endorsement No. 2734/XV, dated 26th August, 1927, I have the honor to state that the Ministerial staff of the whole province of Oudh, holding a conference at Lucknow on 25th and 26th May, 1928, changed the nomenclature of the Civil Courts Clerks Association Lucknow into the "Oudh Civil Courts Ministerial officers Association, Lucknow", having its branches in each district in Oudh, and on 16th July, 1928, submitted an application to the Government of the United Provinces through the honorable the Chief Judge to obtain its official recognition. The Govt: have kindly accorded official recognition to the Association under G.O. No. 1083/VII-437 dated 17th/27th August, 1928 (copy enclosed).

From time to time the members of the Association hold meetings of the Executive Committee and other meetings as well and the next meeting of the executive committee will take place at Lucknow on Sunday the 23rd November, 1928. The funds of the Association are not sufficient to take buildings in the city on rent for holding the meetings now and then. I, therefore, request that you will be kind enough to allow the Association to hold from time to time its meetings in the premises of the Civil Courts buildings in Lucknow.

Subject - Registration of Associations of Government
servants.

I am directed to refer to the Home Department
letter no.F.16/8/27-Public, dated the 21st May, 1927,
on the subject noted above, and to state for the informa-
tion of the Governor in Council, that a question has been
raised whether instructions can be issued to the Regis-
trar of Trade Unions not to register associations of
Government servants until the question of the applicabi-
lity of the Trade Unions Act to such associations and the
problems arising therefrom are finally settled. There
is no provision in the Act under which such instructions
can be issued to the Registrar nor can the Registrar
refuse registration of associations of Government ser-
vants except under section 7 of the Act. In view of this
and of the fact that the position of associations of
Government servants in relation to the Trade Unions Act
is under their consideration vide Home Department letter
no.F-16/8/27-Public, dated the 22nd December 1927, the
Government of India think it advisable that no associa-
tion formed by Government servants should apply for
registration for the present.

Sir,

With reference to your letter No. 3273/II-145-21, dated December 7, 1927, to the address of the District Judge Lucknow, I have the honour to submit that I deeply regret the delay which was chiefly due to the formation of district Associations throughout the province, a measure which seemed absolutely necessary as preliminary to the constitution of the Provincial Association. The district Associations have now been established in all the twelve districts of the Province of Oudh and I have much pleasure to submit that in terms of the suggestion, so kindly made by the Hon'ble the Chief Judge, contained in your letter under reference, an Association for the entire province has been constituted under the designation of the "Oudh Civil Courts Ministerial Officers Association" at the conference of the delegates from almost all the districts and other members who had assembled at Lucknow on May 25 and 26, 1928. A copy of the proceedings of the said conference together with a copy of the rules and byelaws discussed and passed at that conference is herewith submitted. A list of members and office bearers of the association together with a statement of accounts showing income and expenditure upto 31st March, 1928, of the association which was then in existence under the name and title of the "Civil Courts Clerks' Association, Lucknow" is also submitted.
