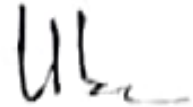

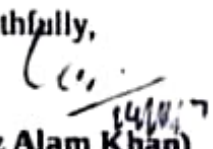

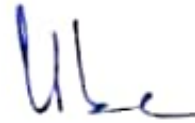

After considering the representations made by Divani Nayalay Karmchhari Sangh, Uttar Pradesh and Anjuman Himayat Chaparasiyan, Uttar Pradesh, I am directed by the Hon'ble Court to say that

- I.** Immediate steps be taken with respect to filling up all the promotional posts from Class IV to Class III and promotion of Class III employees to the higher cadre within 03 months. However, till the recruitment on the feeding cadre is made, the incumbent promoted to the higher cadre from Class III post, be asked to work on the post he was earlier holding.
- II.** All medical reimbursement claims be processed, within a month from the date of receipt.
- III.** The application seeking appointment under the Dying-in-Harness Rules be processed, after completing all the formalities required, within three months from the date of receipt of such application.
- IV.** Retiral benefits be extended to the retired employee immediately and the pension paper be transmitted to the Competent Authority, expeditiously, without any delay.
- V.** Dress to the Class IV employees be provided, subject to availability of the budget in the judgements and, if needed, demand may be sent to the Hon'ble Court.

You are, therefore, requested to strictly ensure the directions of the Hon'ble Court, as above, and send report within a fortnight, positively.

- III.** Application seeking appointment under Dying-in-Harness Rules are pending for more than three months in 41 districts.
- IV.** Retiral benefits, where pension papers are not transmitted to the competent authority, are pending in 37 districts.
- V.** Matters where Dress to the Class IV employees has not been provided, are pending in 35 districts.

The aforesaid data with details and district wise, was placed before Hon'ble the Chief Justice. His Lordship has expressed displeasure on the state of affairs and has directed that the aforesaid pending applications as well as matter of promotion of Class III & IV employees of the Subordinate Courts, be disposed of positively within one month from today, otherwise an explanation may be called for non-compliance of the orders of Hon'ble the Chief Justice.

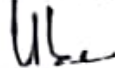

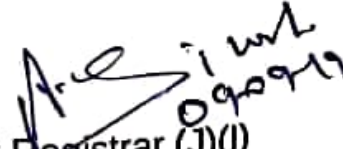

- I. Filing up all the promotional posts from Class IV to Class III and promotion of Class III employees to the higher cadre, within 03 months and till recruitment in feeding cadre is made, the incumbent be asked to work on the post he was earlier holding.
- II. Processing of all medical reimbursement claims within a month from the date of receipt.

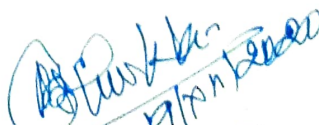

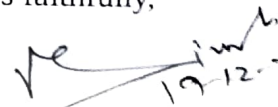
